### **Constitution and Laws**

TITLE FOUR: GRAND LODGE BY-LAWS ARTICLE IX. MEMBERSHIP

### Section 1. Candidates, Petitions, Initiation & Advancement

### Part 12. Candidate Advancement.

- (a) Advancement Defined. Advancement denotes the conferring of a degree after the first has been conferred. This is subject to the provisions of the 4th Gen. Reg. See also yet Gen. Reg.
- (b) Examination. The examination of a candidate as to his proficiency in any of the three degrees must be held in a tyled lodge and only while the lodge is at labor on the degree in which he is to be examined.
- (c) No Vote for Advancement. No vote or ballot shall be taken for the advancement of a candidate except in such cases as the Grand Lodge provides.

### Part 13. Objections to Candidate Advancement.

- (a) Objection to Advancement. When a candidate has received the Entered Apprentice Degree or the Entered Apprentice and Fellow Craft Degrees and objection is made to his advancement, he must be advanced within one year from the date of such objection, \_\_ unless charges are preferred and accepted by the lodge within such year.
- **(b)** Disregard of Objections. A lodge may disregard a protest against the advancement of a candidate.

- (c) No Vote to Stay Advancement. A lodge cannot, by vote, stay the advancement of a candidate beyond the regular time, but the Master may in his discretion refuse to proceed in a proper case.
- (d) No Compelling Reasons for Objection. A member protesting against the advancement of an E.A. or F.C. cannot be compelled to give his reasons for such protest.

Part 14. Failure of Candidate to Appear for Advancement. If an Entered Apprentice or Fellow Craft fails to present himself for advancement within two years after having been requested in writing to do so, he shall forfeit his right to advancement, unless, by a vote of the lodge, taken previous to the expiration of the said period, the time shall be extended. In case an Entered Apprentice or Fellow Craft Mason has forfeited his right to advancement as herein provided, he may request advancement in writing and such request shall take the same course as a petition for affiliation and no fee shall be required.

Part 15. *Candidates from Foreign Jurisdictions*. Lodges of this jurisdiction shall not communicate directly with lodges of other Grand Jurisdictions relative to requests for waiver of territorial jurisdiction or the advancement of candidates. Such correspondence must be submitted to the Grand Master, through the Grand Secretary.

Part 16. *Candidates from Other Lodges*. No lodge working under this jurisdiction shall confer the degree of Fellow Craft or Master Mason upon any brother who has been initiated or passed (as the case may be) in any other lodge, unless the brother applying shall produce a recommendation or certificate of good standing from the lodge in which he was elected, with a request for the conferring of such degree by courtesy, or the brother shall make application for affiliation, in such cases as the Grand Lodge may provide. [Gen. Reg. Paragraph 3 above, repeated here for references purposes]

Part 17. *Candidate Instruction*. The use for the purpose of instruction of, or learning by candidates, of any book, document or paper, written or printed, or in cipher, purporting to be the secret ritual of Freemasonry, other than the authorized Ritual Cipher (or parts thereof) copyrighted by this Grand Lodge, is prohibited.

Part 18. *Master Mason Examination*. Each Master Mason, within three months after he is raised, shall pass a satisfactory examination of the vital parts of the Master Mason degree, unless (for sufficient reason to be stated on the record) an extension, or extensions of time shall be granted by the Worshipful Master. In the event, however, such examination is not passed within one year after the Master Mason is raised, he shall be automatically suspended from membership unless an extension or extensions of time beyond such one year period shall be granted by the Most Worshipful Grand Master. In the event of such suspension from membership, the suspended Master Mason may request reinstatement in writing. Such request shall take the same course as a petition for affiliation and no fee shall be required. The Grand Secretary shall be notified immediately in writing of the date that the Master Mason passed the examination or was suspended.
